

1. that the estate of First Respondent is placed under provisional sequestration in the hands of the Master of the above Honourable Court;
2. that a rule nisi do hereby issue calling upon First Respondent and all other interested parties, if any, to show cause to this Honourable Court on **MONDAY, 18 OCTOBER 2021** at 10:00 or as soon thereafter as the matter may be heard, why an order in the following terms should not be granted:
 - 2.1 that First Respondent's estate be placed under final sequestration;
 - 2.2 that the costs of this application should be costs in the sequestration;
3. that service of a copy of this order in this application be effected:
 - 3.1 on the Respondents personally by the Sheriff of the above Honourable Court;
 - 3.2 on the local offices of the Receiver of Revenue by the Sheriff of the above Honourable Court;

- 3.3 on First Respondent's employees (if any) by the Sheriff of the above Honourable Court as well as on any trade unions of which such employees may be members (if any);
4. the Sheriff is to attach all moveable property of the insolvent estate and shall immediately after effecting such attachment, report to the Master in writing that the attachment has been effected and is to submit with such report a copy of the inventory in terms of Section 19(1) of the Insolvency Act, No. 24 of 1936.
