- 7. The Liquidators are also investigating the whereabouts of further movable assets, a report will be sent in due course if deemed necessary.

SECTION 402 (b) - CAUSES OF THE FAILURE OF THE COMPANY

The Company was commercially Insolvent, a voluntary application by way of Special Resolution was lodged by the Executor for the Deceased Mr. F Dingani, the business was beyond saving and could not meet its monthly payment obligations to Creditors.
