# INSOLVENT ESTATE: THE HEINEMAN TRUST MASTER'S REFERENCE: S27/2022

REPORT OF THE JOINT TRUSTEES CHAVONNES BADENHORST ST CLAIR COOPER AND AVIWE NTANDAZO NDYAMARA IN TERMS OF SECTION 81 OF THE INSOLVENCY ACT, NUMBER 24 OF 1936, AS AMENDED, TO BE SUBMITTED AT THE SECOND MEETING OF CREDITORS TO BE HELD BEFORE THE PRESIDING OFFICER, THE MASTER PORT ELIZABETH, ON WEDNESDAY THE 15th FEBRUARY 2023 AT 14H00.

#### **INTRODUCTION**

The estate of THE HEINEMAN TRUST (IT: 70/2001(E)) was sequestrated on the 28<sup>th</sup> of June 2022 by way of a Court Order issued by the High Court (Eastern Cape Gqeberha Division).

The First Meeting of Creditors was convened by the Master Port Elizabeth to take place on 16<sup>th</sup> November 2022, the claims of Pegasus & Company (Pty) Ltd and Absa Bank Limited were submitted and successfully proved at the Meeting

We were appointed Provisional Trustees by the Master of the High Court on the 29<sup>th</sup> of August 2022 and the appointment was made final on the 16<sup>th</sup> of November 2022.

The insolvent estate had its registered address at: 5 Scott Street, Summerstrand, Port Elizabeth

The Trustees of the Trust at date of Sequestration were Heinrich Tertius Bruyns, Heinrich Werner Bruyns, Lirene Bruyns, Larissa Bruyns, Luzanne Bruyns and Johannes Jacobus Scheepers (Snr)

The Appointed Trustees were not furnished with the completed STATEMENT OF AFFAIRS by the former Trustees.

- 2. No claims of SARS have been received yet.
- 3. There appears to be no Danger of Contribution in this Estate at the moment, the Trustees will advise All Known Concurrent Creditors if a dividend will be available before submitting claims at a Special Meeting of Creditors.
- 4. The Appointed Provisional Trustees approach the High Court (Eastern Cape Division Gqeberha) for extension of Powers in terms of Section 18(3) to sell The assets of the Insolvent Estate and to appoint Legal advisors to collect outstanding debtors, the said order was granted 01<sup>st</sup> of November 2022.
- 5. The Trustees are in the process of collecting further debtors, if deemed necessary and with consent from Creditors proceed with legal action to collect further monies owing to the Insolvent Estate.

#### SECTION 81 (1) (b) - REASONS FOR INSOLVENCY

The Trust experienced financial problems during the tough financial times when regular payments to creditors could not be met, The Trusts main asset was a Garage in Bluewater Bay that was sold, to date there is a balance outstanding on the Purchase Price due and payable.

## SECTION 81 (1) (e) - BOOKS AND RECORDS

The Trustees were furnished with certain books & records.

#### SECTION 81 (1) (d) - CONTRAVENTIONS

I am not aware of any contraventions of the Insolvency Act, excepting that the insolvent did not comply with Sections 16(2)(b).

No allowances were made to the Trust.

## SECTION 81 (1) (f) - CARRYING ON OF BUSINESS

No Business was conducted for or on behalf of the Trust.
