Having heard counsel for the applicant, and having read the papers filed of record;

IT IS ORDERED THAT:

1. The estate of the First Respondent, one Abrie Botha, is placed under provisional sequestration in the hands of the Master of the above Honourable Court.

2. A rule *nisi* is issued calling upon all effected parties to show cause, if any, to the above Honourable Court on **14 December 2021** at 10h00 or soon thereafter as counsel for the applicants may be heard as to why an order in the following terms should not be granted:

2.1 a final order of sequestration;

2.2 that the cost of this application should be cost in the sequestration;

2.3 such further and/or alternative relief be granted to the applicants.

3. Service of this provisional order be affected:

3.1 by the Sheriff of this Honourable Court upon the First and Second Respondents personally;

3.2 by the Sheriff of the Honourable Court upon the employees, if any,

of DRS Dent Repair Solutions (Pty) Ltd (if it be ascertained that DRS

Dent Repair Solutions (Pty) Ltd does have employees) by affixing a

copy thereof to any notice board to which the employees have



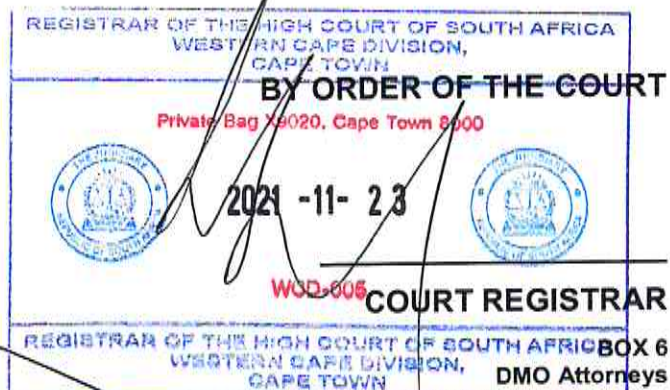
access inside the premises or by affixing a copy to the front door of the premises from which the DRS Dent Repair Solutions (Pty) Ltd conducts business;

3.3 by the Sheriff of the Honourable Court on every trade union, if any, that represents any employees of DRS Dent Repair Solutions (Pty) Ltd;

3.4 by the Sheriff of this Honourable Court upon the offices of the South African Revenue Services at 22 Hans Strijdom Avenue, Cape Town;

3.5 By publication in each of the 'Die Burger' and 'Cape Times' newspapers.

4. The Sheriff of this Honourable Court is directed to attach all property which appears to belong to the First Respondent and transmit to the Master of this Honourable Court an inventory of all property attached by him or her in terms of Section 19 of the Insolvency Act 24 of 1936.
