2.1 the Respondent should not be placed under final liquidation; and

2.2 that the costs of this application should not be costs in the liquidation of the Respondent.

3. Service of this order shall be effected:

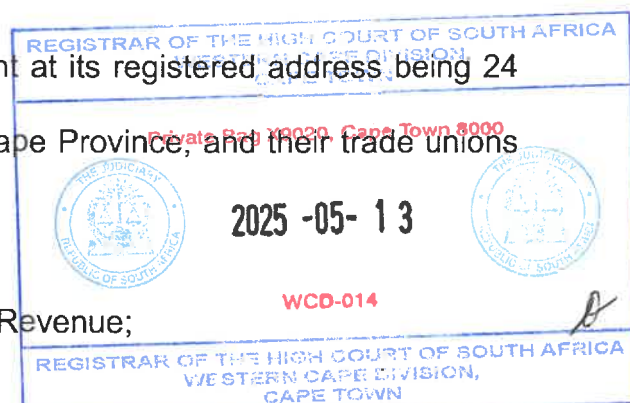
3.1 on the Respondent at its registered address being 24 Prima Drive, Strand, Western Cape Province;

3.2 on the employees of Respondent at its registered address being 24 Prima Drive, Strand, Western Cape Province, and their trade unions (if any);

3.3 on the offices of the Receiver of Revenue;

3.4 by one publication in each of "*The Cape Times*" and "*Die Burger*";

3.5 by service of a copy of the order by registered post on all known creditors of the Respondent with claims in excess of R5 000,00.

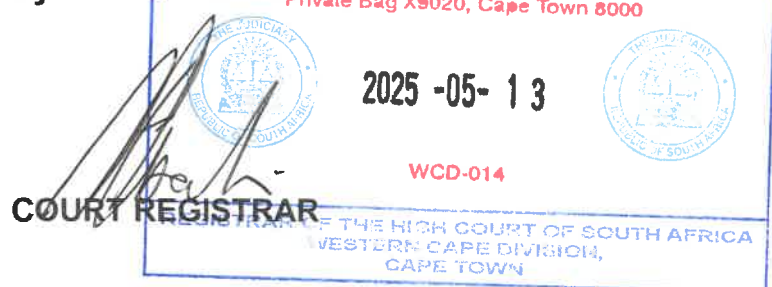

- 4 The Registrar shall transmit a copy of the winding-up order to the Sheriff of the province in which the registered office of the Respondent is situate and to the Sheriff of every province in which it appears that the Respondent owns business.
- 5 The Sheriff shall attach all property which appears to belong to the Respondent and transmit to the Master an inventory of all property attached by him or her in terms of Section 19 of the Insolvency Act 24 of 1936.
