

**IT IS ORDERED THAT:**

1. The *rule nisi* granted by the Honourable Mr Justice Dolamo on 27 February 2025 under the above case number, is hereby made final;

The applicant is authorised to take and retain possession of the respondent's business and/or its movable assets hypothecated as security, and to deal with those assets in terms of clauses 14.2, 14.3, 14.4, 14.5 and 14.6 of the notarial bond registered with the Registrar of Deeds under number BN23584/2024 ("**the bond**");

3.
