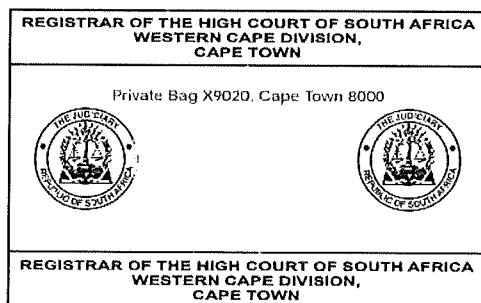

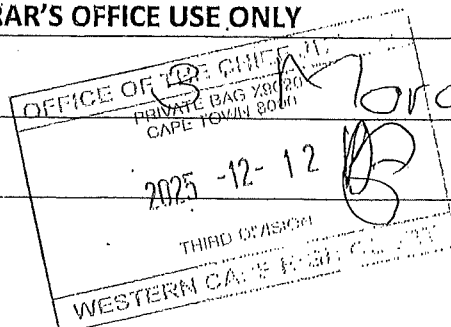

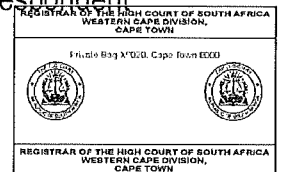

NOTICE OF MOTION

BE PLEASED TO TAKE NOTICE that application will be made in the above Honourable Court on behalf of the abovementioned Applicant on TUESDAY the 3rd day of MARCH 2026 at 10h00 or as soon thereafter as Counsel may be heard, for an order in the following terms:

1. That the Respondent be placed under provisional liquidation.
2. That a *Rule Nisi* be issued, calling upon all interested persons to show cause, if any, on a date to be determined by the above Honourable Court as to why an order in the following terms should not be granted:
 - 2.1 That the Respondent be placed under final liquidation;
 - 2.2 That the cost of this application be costs in the liquidation of the Respondent.

3. That service and publication of the provisional liquidation order and *Rule Nisi* granted in terms of paragraphs 2 and 3 above shall be effected as follows:

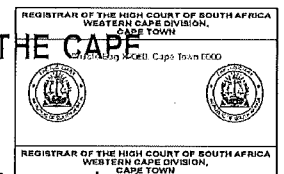
3.1 that a true copy thereof shall be served on the Respondent at its registered address by the Sheriff or his deputy;

3.5 that a true copy thereof shall be sent to all known creditors of the Respondent exceeding claims of R20 000.00.



4. That, if at the time of the winding up of the Respondent, the Respondent is in final deregistration that the Respondent's dissolution be declared void by the above Honourable Court in terms of Item 9 of Schedule 5 of the Companies Act No. 71 of 2008 read with section 420 of the Companies Act No. 61 of 1973.

5. Further and/or alternative relief as the above Honourable Court may deem fit.

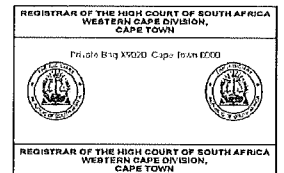

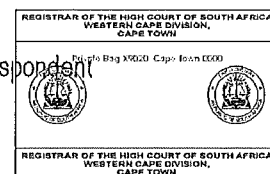

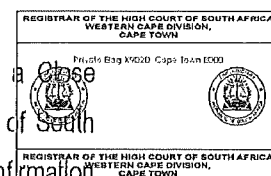

3. The facts and allegations contained herein are, save where the context clearly indicates the contrary, within my personal knowledge and are to the best of my belief both true and correct.
4. Where I refer to information conveyed to me by others, I verily believe such information to be true. Where I make legal submissions or conclusions, I do so on the advice of my legal representatives, which advice I believe to be true and correct.

THE APPLICANT

5. The Applicant is **AGRIJOR CC** (Registration number: B2010/155664/23), a Close Corporation duly incorporated as such in terms of the laws of the Republic of South Africa with its registered address at 18 Schroder Street, Uptington. In confirmation thereof I hereto annex a copy of an electronic CIPC search performed on the Applicant marked annexure "FA2".



THE RESPONDENT

6. The Respondent is **E A Logistics (Pty) Ltd** (registration number: K2013/026051/07) a private company with limited liability duly incorporated as such in terms of the laws of the Republic of South Africa, with its registered at 9 Geelhoutlaan, Greenoaks, Paarl, a copy of the electronic CIPC search result is annexed hereto marked as annexure "FA3".
7. As appears from annexure "FA3" and at the time of deposing hereto the Respondent has been in deregistration process since 13 September 2025. If, at the time of the winding up of the Respondent, the Respondent remains in deregistration process, the Applicant's relief sought in this application shall remain the same.
8. If, however, the Respondent is placed in final deregistration at the time of the winding up of the Respondent, I respectfully submit that it would be just and equitable for the

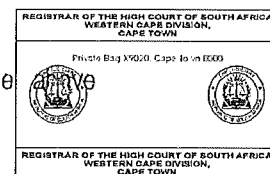

respondent's dissolution to be declared void by the above Honourable Court in terms of item 9 of Schedule 5 of the Companies Act No. 71 of 2008 read with section 420 of the Companies Act No. 61 of 1973.

LOCUS STANDI AND JURISDICTION

9. Respondent is indebted to the Applicant in the amount of R425 649.84 (Four Hundred and Twenty-Five Thousand Six Hundred and Forty-Nine Rand and Eighty-Four Cents) in respect of transport services rendered.
10. As stated above, the Respondent's registered address lies within the Honourable Court's area of jurisdiction.
11. Accordingly, the Applicant has the necessary *locus standi* to bring this application and the above Honourable Court has the necessary jurisdiction to hear same.



PURPOSE

12. This is an application for the winding up of the Respondent on the basis that it is unable to pay its debts in terms of Sections 344(f) and 345(1)(c) of the Companies Act No. 61 of 1973 (as amended) (hereinafter referred to as "the Act") read with item 9 of Schedule 5 to the Companies Act No. 71 of 2008 (hereinafter referred to as "the Companies Act") and/or that it is just and equitable for the Respondent be wound up in terms of Sections 344(h) of the Companies Act No. 61 of 1973 (as amended).

BACKGROUND AND APPLICANT'S CASE FOR WINDING

13. Applicant provided transport services to Respondent. Respondent is indebted to the Applicant in the amount of R425 649.84 (Four Hundred and Twenty-Five Thousand Six Hundred and Forty-Nine Rand and Eighty-Four Cents), which sum is (over) due and payable by the Respondent to the Applicant and is not disputed by the Respondent. As

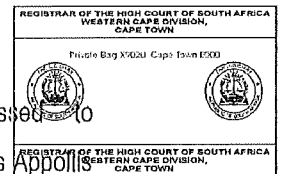

proof thereof a copy of the Applicant's statement is annexed hereto marked annexure "FA4".

14. Accordingly, on or about 21 January 2025, a formal written demand in terms of Section 345 of the Act was served on the Respondent by way of e-mail and served by the Sheriff of the Court on 4 February 2025. As proof thereof, I respectfully refer to the following documents attached hereto:

- 14.1 Annexure "FA5" being a copy of the formal letter of demand (and annexure "A" & "B" thereto) dated 21 January 2025; and

- 14.2 Annexure "FA6" being a copy of the e-mail addressed to eaologistics25@gmail.com, which e-mail address is that of Mr Andreas Appollis (the Respondent's director), dated 21 January 2025;



- 14.3 Annexure "FA7" being a copy of an e-mail received from the Respondent confirming receipt of the letter of demand.

- 14.4 Annexure "FA8" being a copy of the Sheriff's Return of Service confirming service of said demand at the Respondent's registered address on 4 February 2025.

15. In light of the above, the Applicant has a liquidated claim against the Respondent, being the unpaid balance for services rendered to the Respondent (the debt) which, at the time of deposing hereto, amounts to R425 649.84. Further, the Applicant holds no security for its claim against the Respondent.

16. Since service of the abovementioned demand, the statutory period of 21 days as contemplated in Section 345 of the Act has lapsed. In that time, the Respondent has failed to pay the amount demanded (or any portion thereof) and/or has failed to secure or compound it to the reasonable satisfaction of the Applicant.

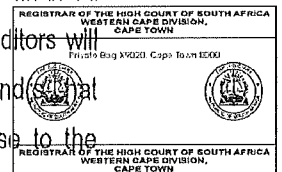

17. I am advised that the facts stated above are sufficient to establish that this Honourable Court is entitled to grant a winding up order as prayed.
18. Because this is a so-called "arm's length" application, the Applicant's knowledge of the Respondent's financial position is limited to what is set out above.

URGENCY

19. It is my respectful submission that the continuation of the Respondent's financial hardships will inevitably mean that the extent of its exposure towards its creditors will only increase over time and, unless a *concursum* is urgently formed, the dividend that will eventually accrue to the general body of its creditor will only decrease to the obvious detriment of its creditors.



20. This being the case, I respectfully submit that it will also be just and equitable for a winding-up order to be granted so that liquidators can be appointed to take control of the Respondent's affairs and to realize its assets and distribute the proceeds of same in accordance with the statutory order of preference.

FORMALITIES

21. I shall ensure that this application is served on the Respondent, the Master of the above Honourable Court, the South African Revenue Service and on the Respondent's employees (if any) as well as on any registered Trade Unions that may represent said employees. Further, due security shall be furnished to the Master of the above Honourable Court for the payment of all fees and charges necessary for the prosecution of these winding up proceedings and of all costs of administering the Respondent in liquidation until a liquidator has been appointed, prior to the hearing of this matter.
22. The Sheriff will be instructed to make the necessary enquires when serving a copy of this application at the Respondent's registered address to establish whether the

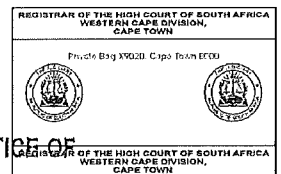

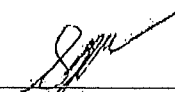

23. I shall, prior to the hearing of this matter cause an affidavit to be delivered which sets out the manner in which service of this application has been effected on the aforesaid persons and entities.

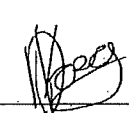
24. In the premise, I respectfully pray that it may please the above Honourable Court to grant the relief sought in the notice of motion to which this affidavit is annexed.
