DRAFT ORDER

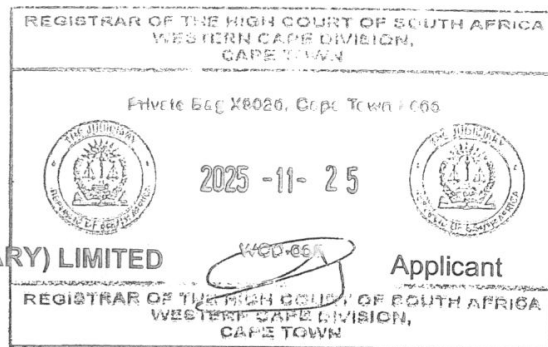
Having read the papers filed of record and having heard counsel for the applicant;

IT IS ORDERED THAT:

1. The applicant is placed under provisional winding up in the hands of the Master of
the High Court.

2. A *rule nisi* is issued calling upon all interested persons to appear or to show cause,
if any, on 17 FEBRUARY 2026 why the following relief should not
be granted:

2.1. why the applicant should not be placed under final winding up;



- 2.2. why the costs of this application should not be costs in the liquidation of the applicant.
3. Service of this provisional order must be effected as follows:
- 3.1. by one publication thereof in one edition each of the *Cape Times* and *Die Burger* newspapers;
- 3.2. on the South African Revenue Services; and
- 3.3. by pre-paid registered mail on all known creditors with claims of more than R20,000.00.
4. The Registrar is directed to transmit a copy of this order to the Sheriff of the province in which the registered office of the applicant is situate and to the Sheriff of every province in which it appears that the applicant owns business.
5. The Sheriff is directed to attach all property which appears to belong to the applicant and transmit to the Master an inventory of all property attached by him or her in terms of section 19 of the Insolvency Act 24 of 1936.
